## QUALIFICATIONS

Qualified commercial natural gas foodservice equipment eligibility:

- A. Equipment must be listed on one of the following accredited websites:
  - ENERGY STAR EnergyStar.gov/cfs
  - Food Service Technology Center (FSTC) Fishnick.com/saveenergy/rebates
- B. Only new equipment is eligible for rebate (no refurbished equipment).
- C. New construction and replacement equipment installations are eligible.

## REQUIREMENTS

1. All qualifying equipment must be fully installed and operational, and is subject to inspection by AOG or an agent of AOG's choosing.
2. Enclose invoice showing separate figures for equipment, labor, and taxes.
3. Enclose all nameplate data and age of equipment being replaced, if applicable.
4. All required information must be submitted before the rebate can be paid.
5. The rebate application form must be submitted within 90 days of installation or postmarked by December 31st, 2018 whichever comes first.

**Equipment installed under warranty replacement does not qualify for the rebate.**

Rebate qualifications and amounts are subject to change. Rebate funds are limited. Completed rebate forms will be processed in the order in which they are received. Arkansas Oklahoma Gas rebate programs may be cancelled or changed at any time.

**This program ends December 31, 2018.**

**Rebates will not be paid if funds are depleted prior to December 31, 2018.**
