QUALIFICATIONS

The qualifying equipment must be installed in a home or business served with natural gas from Arkansas Oklahoma Gas and must meet the following efficiencies:

| EQUIPMENT | EFFICIENCY LEVEL* | CUSTOMER REBATE | INSTALLER REBATE |
|---------------------|--------------------|-----------------|------------------|
| Natural Gas Furnace | 90% to 94.9% AFUE | \$300 | \$ 50 |
| Natural Gas Furnace | 95% AFUE or higher | \$500 | \$ 50 |

Efficiency Level: EF = Energy Factor, TE = Thermal Efficiency, AFUE = Annual Fuel Utilization Efficiency

Rebate offer applies only to new natural gas furnaces.

Arkansas Oklahoma Gas uses AHRI (Air Conditioning, Heating & Refrigeration Institute) listings to determine the efficiency of the equipment. Equipment must be certified by AHRI.

Heating dealers are not eligible to receive their customer's rebate.

Building contractors should negotiate with homeowners to determine who receives the rebate.

Equipment installed under warranty replacement does not qualify for the rebate.

APPLICATION REQUIREMENTS

The rebate application form must be submitted within 90 days of installation date or postmarked by December 31, 2018 whichever comes first! Application must be completely filled out with purchaser information, equipment information (including brand, complete model number, serial number, installation date and AFUE rating), and dealer and installer information. Arkansas Oklahoma Gas is unable to accept applications that do not include all this information. A copy of the dated invoice or sales receipt must accompany the completed rebate application and must include the following information: brand, complete model number and serial number. It is the responsibility of the dealer and purchaser to ensure that the installed equipment qualifies for the rebate. If it does not qualify, no rebate will be paid.

Arkansas Oklahoma Gas reserves the right to inspect the installed equipment.

Rebate qualifications and amounts are subject to change. Rebate funds are limited. Completed rebate forms will be processed in the order in which they are received. Arkansas Oklahoma Gas rebate programs may be cancelled or changed at any time.

This program ends December 31, 2018.

Rebates will not be paid if funds are depleted prior to December 31, 2018.

REBATE DETAILS

Rebate amounts will be issued for equipment installed between January 1, 2018 and December 31, 2018 only. Arkansas Oklahoma Gas issues cash rebates in the form of checks, not utility bill credits. Arkansas Oklahoma Gas is not responsible if the dealer does not provide accurate information about the amount of rebate or equipment eligibility. Rebate checks will be mailed within 4-6 weeks.
